## Narrative:

At 0800 hours, on 05-05-15, within King County Washington; I was assigned to be the lead Detective in a stalking and intimidating a public servant investigation involving a Duvall Police Sergeant who resides in the City of Shoreline. I am keeping her address private and for the purposes of this case I am using KCSO Precinct #5 as the location. The victim is Sergeant Lori Batiot with the Duvall Police Department. The suspect in this case is S-Anne K. Block DOB 03-16-67 and she currently resides in Gold Bar Washington. Additional person(s) of interest in this investigation are Private Investigator Neil R. Harrison DOB 12-21-57 with a confirmed State of Washington PI license #3429. The second POI is believed to be a male who resides with S-Block by the name of Noel R. Frederick DOB 12-24-57.

## Summary of facts:

On 04-17-15, V-Sergeant Lori Batiot was working as an on-duty commissioned Police Officer for the City of Duvall. V-Batiot was contacted by Duvall resident(s) John and Crystal Pennington regarding a stalking/harassment complaint that had been ongoing since 2009. V-Batiot opened an official and lawful criminal investigation into the matter under Duvall PD case #15-00423D and after her interviews with the V-Pennington(s) and a review of the evidence V-Sergeant Batiot determined it was valid complaint and during the course of her investigation she attempted to contact S-Anne Block to conduct and interview and get her side of the story before forwarding the case for review. This is a common and accepted investigative step in any criminal investigation and completely lawful in nature. This contact attempt via phone took place on or about 04-12-15.

Victim Sergeant Batiot left a voicemail for S-Block but never received a return call. At some point in the near future V-Sergeant Batiot received email and Twitter messages from S-Block that were not responsive to her request for an interview and this started an on-going clear and consistent pattern of harassment targeting V-Sergeant Batiot and the City of Duvall. V-Sergeant Batiot had simply asked for an interview due to the criminal complaint and wanted to see if S-Block wanted to provide her side of the events to be included in the case. This being a fully lawful and investigative technique that is accepted nationwide and completely reasonable in nature. S-Block simply had a choice to respond by providing an interview or declining.

Almost immediately V-Sergeant Batiot only made the initial phone call with the voicemail left with her professional contact information that included two phone numbers she was available at. V-Sergeant Batiot responded to one email specifically explaining she only wished to get her side of the events involving the allegations against her before forwarding the case to the Prosecutor for review. At this point the Twitter messages with strange contact indicating S-Batiot was now a corrupt Officer and Duvall is now a RICO defendant and so on and so forth. V-Batiot has all the documentation in her 13 page

massive blanket Public Disclosure Request to the City of Duvall for hundreds of records clearly so S-Block could use whatever she received to continue to harass V-Sergeant Batiot online. S-Block made a few FaceBook comments to the Duvall Police FB page that were clearly in-appropriate in nature and were to opening harass V-Batiot and had no other value than that. Screen shots of that post are included in the attachments and will be referenced in my follow up report specifically.

On 04-14-15, V-Sergeant Batiot received a phone call on her personal cell phone that is unpublished and not available to the general public. This call came from a male who identified himself as S-Neil Harrison as a Private Investigator. His call came as "Restricted" but he identified himself and provided his number as 425-239-2315. S-Harrison was very intimidating towards V-Sergeant Batiot. V-Batiot was now very concerned as this was no longer a standard "Police Work" issue as S-Block is now turning a simple interview request in a valid criminal investigation into a personal issue with her. This is a very valid concern for any Law Enforcement Officer. S-Harrison made a comment that he was trying to help keep Sergeant Batiot out of "Federal Prison" and wanted to ask her a few questions. I find this request odd that he through his client S-Block who he identified, refused to respond to V-Sergeant Batiot's valid request to provide an interview and started this on-going pattern of harassment due to it and now through a PI she is trying to interview her. That makes no sense. V-Batiot did not answer any questions and cautiously warned S-Harrison about the on-going harassment and not to get caught up in aiding and abetting S-Block. V-Batiot also made it clear to S-Harrison that she no longer was assigned or working the S-Block investigation and any additional inquires must be made to her Commanders.

The fact that this has gone from a pattern of harassing and stalking V-Sergeant Batiot and trying to damage or destroy her professional career and naming her in a Federal Lawsuit for RICO violation(s) and making FaceBook posts etc. It is also obvious that S-Block is going after this harassment under the guise of being a "Reporter" and using email addresses from the Gold Bar Reporter and other unconfirmed local media type sites. As time goes on S-Block continues to harass and email V-Sergeant Batiot by accusing her of having a personal relationship with the V-Pennington(s) and calling them wife and child abusers and Pedophiles.

During the course of Sergeant Batiot's initial investigation from the V-Pennington(s) she was aware that S-Block had sent her investigator(s) to the V-Pennington's residence where they knocked and spoke with one of there children. This, coupled with the fact that S-Harrison was able to locate her private cell phone number raises her concerns for her safety and the safety of her family at her personal residence. This concern appears to be a valid one as at 0200 hours on the evening of 04-19-15 an unknown person but suspected to be associated with S-Block had started pounding on her door. The pounding continued on and off for approximately two minutes and as she got close to the door it stopped and the person(s) were gone. V-Sergeant Batiot has never had this happen before and believes it is associated. V-Sergeant Batiot called the King County Sheriff's Office with a request to have a patrol response come check her residence and surrounding area to be sure the person(s) were in fact gone. Shoreline Deputies checked the area and determined they were in fact gone. This area check was conducted under KCSO 15-108902 and that report is incorporated by reference.

In my review of this incident I have found that the City of Duvall Municipal Prosecutor does have a misdemeanor case read to file against S-Anne Block for misdemeanor harassment and a misdemeanor unlawful practice of law due to S-Block doing official lawyer work while confirmed to have her BAR license suspended. In light of these new harassment and intimidation of a public servant investigation we have asked them to hold off while we conduct our portion of the investigation and if new felony charges are warranted I will absorb the Duvall case under their case(s) numbers and file everything with the King County Prosecutor. This is still an on-going felony criminal investigation.

This is a very basic summary of the main events but not everything contained in the massive stack of paperwork. I will be assigned as the lead investigator and will open a standard follow up to document the investigative steps and necessary charging documents.
