**Subject:** Washington State Attorney General Advising County Employees to break the law

I recently received some records from Pierce County which confirmed my suspicions that the Washington State Attorney General is an accomplice to many inappropriate and illegal city, county and state actions.

In this email, Ms Robnett from the Washington State Attorney Generals Office is directing a Pierce County Employee Gregory Greer on how to destroy records. **I have included screenshots and the actual email with metadata**

It is an open discussion directly from the AG's Office, to a county agency by the very same woman who started the worst public records case by claiming that Glinda Nissen threatened to kill her.

The same woman who has accepted over 6000.00 from the Nissen family in her bid to take over as the Pierce County Prosecutor, the very same woman who had the texts in question that were withheld to protect her, but once she decided she wanted to run, she magically "realized" that she had those texts "the whole time".

I am calling for a criminal investigation into this matter and I would advise you Mr Ferguson to begin before elections. The actions described below fall into a felony crime under 40.16.010. I will be making a request to your office for these same exact emails, if they are not available then I will know that your own office regularly destroys public records in violation of the law. I'm including screen shots but also the original email with the metadata.

**RCW 40.16.010 Injury to public record. Every person who shall willfully and unlawfully remove, alter, mutilate, destroy, conceal, or obliterate a record, map, book, paper, document, or other thing filed or deposited in a public office, or with any public officer, by authority of law, is guilty of a class C felony and shall be punished by imprisonment in a state correctional facility for not more than five years, or by a fine of not more than one thousand dollars, or by both.**

I am hoping that you, Mr Lindquist will address this attempt at a criminal activity with the employee in question. The Public Records Act and Government offices are a public trust, and I will expect quick, effective action on your part in this very serious criminal matter. Since it's apparent that Mr Greer was unable to destroy public records it is still a crime to attempt to do so.

I sincerely hope you learned your lesson about "protecting your employees" and I am very disappointed that in your effort to protect this woman that you have never publicly stated that SHE is the cause of Nissen v Pierce County. If in fact these records had to be recovered then he did commit a felony as described above and I hope that you will take appropriate legal measures to remedy this situation.

I would also like a statement from you Mr Greer of the names of everyone in your office "that is capable of nothing" and how you arrived at that conclusion. I think the public has the right to know if the office is being run by imbeciles as you infer to Ms Robnett.

Either way I am looking for an attorney to begin a legal claim against the AG's Office. You are the office that is supposed to teach all other agencies to correctly and legally provide records to the public. If this is what you're office is teaching them then the PRA needs to be revamped to protect it from the likes of you
